127 total claims were decided by the Board for September 2024.

Board Chair Parsons called the meeting to order at 10:07 AM and conducted roll call.

The following were in attendance at this month's meeting: Chair Parsons, Members Leenerts and Roberts, Executive Director Hardesty, Staff Attorneys Bevins-Sullivan and Horsman, Executive Staff Advisor Shields, Investigators Hubbard and White, Victim Advocate Hopson, and Restitution/Collections Officer Barrie.

Member Roberts motioned to adopt the September 2024 minutes. Member Leenerts seconded the motion. Having all in favor, the motion carried. The September 2024 minutes were officially adopted.

Executive Director Hardesty gave his Executive Director's report to the Board. The agency has officially received approval to hire three (3) additional staff members for the CVC/SAE program. Two (2) of these individuals will serve as CVC claims investigators and the remaining individual will work with the SAE program. All three (3) positions are ready to post to the register. The next three (3) individuals that may be hired in the near future will serve as follows: two (2) additional CVC claims investigators and the remaining individuals' duties have not been determined as of yet.

Executive Director Hardesty advised the Board that the CVCB's administrative regulations are far along in the process. The goal is to present the proposed regulations to the Board for review and potential approval in either November or December 2024. After Board approval, the regulations will go through the normal promulgation process.

Executive Director Hardesty advised the Board that Executive Staff Advisor Shields has done quite a bit to ensure that the CVCB is in compliance with the requirements set forth by SB 319.

Executive Staff Advisor Shields provided his report to the Board. The next trainings for the CVC/SAE program have been scheduled for October 18 and November 15, 2024. Sixteen (16) individuals have registered for the October training and three (3) have registered for the November training. Given the low interest, Executive Staff Advisor Shields may cancel the November training.

Executive Staff Advisor Shields advised the Board of the tasks he has undertaken to ensure compliance with the requirements of SB 319:

- Final orders issued by the CVCB can now be uploaded to the website
- The report tracking investigative timeframes is being tweaked to address some minor issues. The report should be good to go well ahead of the July 1, 2025 and July 1, 2026 deadlines.
- The report tracking emergency request timeframes is good to go and the Board currently is in full compliance with the two-week timeframe requirement.
- SAE claim forms have been revised and are currently awaiting approval and promulgation in the CVCB's forthcoming regulations.
- A draft of the emergency request form has been drafted and is currently awaiting approval and promulgation in the CVCB's forthcoming regulations.

Restitution/Collections Officer Barrie advised the Board that mileage for the period of October 1, 2024 through December 31, 2024 is \$0.43/mile. Staff Attorney Horsman is still looking into the ten-year statute of limitations issue involving the Department of Revenue's collections activities. Restitution/Collections Officer Barrie has talked with Executive Director Hardesty about the possibility of allowing offenders to pay their debts to the CVCB through the CVCB's website.
