91 total claims were decided by the Board for August, 2022.

Board Chair Lanola Parsons called the meeting to order at 10:03 AM and conducted roll call.

The following were in attendance at this month's meeting: Board Chair Parsons, Members Leenerts and Roberts, Executive Director Hardesty, Staff Attorneys Bevins-Sullivan and Lile, Executive Staff Advisor Shields, Investigators Hubbard and White, and Restitution/Collections Officer Barrie.

Member Roberts motioned to adopt the August 2022 minutes as proposed. Member Leenerts seconded the motion. All voted in favor of the motion. The motion carried.

Staff Attorney Bevins-Sullivan provided Executive Director Hardesty's statistical report to the Board in his stead. ESA Shields advised the Board that the next training on the CVC program is scheduled for September 16, 2022 and forty-one people have registered. In addition, trainings have been scheduled for October 21, 2022, December 16, 2022, and January 20, 2023. ESA Shields also advised that he had been asked by Member Roberts to determine the number of claims filed since January 2021 involving Spring Valley Funeral Home and Cremation and provided his findings to the Board.

Executive Director Hardesty reported to the Board that a working group has been formed by KASAP in conjunction with several Senators and other groups to examine the CVC and SAEP programs with an eye to seeing how the programs' operations could be improved upon. The first meeting is scheduled for September 28, 2022. Executive Director Hardesty and others will be in attendance. In addition, Executive Director Hardesty advised the Board that a bill to amend OCA's statutes has been proposed, including proposed amendments to the CVC program, and is currently with the Governor's Office. The Cabinet included its five top priorities for this bill, which includes the proposed increase to the CVCB's statutory caps.

The Board continued discussions into potentially adopting policies for granting bereavement leave and awarding expenses involving emotional support animals. After discussion, Board Chair Parsons motioned to adopt the proposed bereavement policy. Member Leenerts seconded the motion. All voted in favor of the motion. The motion carried. The Board tabled the decision on whether to adopt the emotional support animal policy and wants to have further discussion on the topic.
