Board Chair Parsons called the meeting to order at 10:07 AM and conducted roll call.

The following individuals were in attendance at this month's meeting: Board Chair Parsons, Members Leenerts and Roberts, Staff Attorney Bevins-Sullivan, Executive Staff Advisor Shields, Investigators Hubbard and White, and Restitution/Collections Officer Barrie. Executive Director Hardesty joined virtually via Zoom.

Member Roberts motioned to accept the August 2023 minutes. Member Leenerts seconded the motion. With all voting in favor of the motion, the motion carried.

Executive Director Hardesty gave his Director's Report to the Board. The recent decrease in SAEP claim filings can be attributed to Children's Advocacy Centers working with Medicaid to get victims enrolled in the program. The CAC reimbursement requests are being paid through Medicaid to a greater degree, thus reducing the need for SAEP to pay.

Executive Director Hardesty is currently working on getting Member Roberts scheduled for his trauma informed training for 2023.

Executive Director Hardesty encouraged the Board to go ahead and make recommendations on claims assigned to them and have the Board decide them rather than bringing a claim before the Board before a recommendation is issued. Bringing claims before the Board before issuing a recommendation can add up to thirty days of claims processing time.

Executive Director Hardesty is staying in contact with the Department of Corrections regarding its PIECP program. The program may potentially be expanded by increasing the number of inmates that are participating, which could result in an increase of revenue coming to the Board through the program.

Executive Director Hardesty advised the Board that both he and Executive Staff Advisor Shields will be testifying before the Interim Joint Committee on the Judiciary on September 21, 2023 at 11:00 AM. The next CVC bill will go on the Interim Joint Committee on the Judiciary's agenda on October 13, 2023. Executive Director Hardesty and perhaps others may be asked to accompany Senator Harper-Angel as she testifies before the Committee.

Executive Director Hardesty advised the Board that work continues to be done on hiring the victim advocate. The next task will be the posting of the postion on the register.

Executive Director Hardesty advised the Board that the Office of Justice Programs will be conducting an on-site visit for the program on September 18 and 19, 2023.

Executive Staff Advisor Shields advised the Board that the August 18, 2023 training had seventynine (79) people in attendance, which was the highest total in the history of the program. The September 15, 2023 training currently has fifty-two (52) registrants. Trainings for the rest of the year have been scheduled: October 20, 2023 and November 17, 2023.
