91 total claims were decided by the Board for August 2024.

Board Chair Parsons called the meeting to order at 10:07 AM and conducted roll call.

The following were in attendance at this month's meeting: Board Chair Parsons, Members Leenerts and Roberts, Executive Director Hardesty, Staff Attorneys Bevins-Sullivan and Horsman, Executive Staff Advisor Shields, Investigators Hubbard and White, and Restitution/Collections Officer Barrie. Claimants I.C. and T.C. were also in attendance.

Executive Director Hardesty gave his Executive Director's Report to the Board. Approval is currently pending on three (3) additional staff members, for a total of six (6).

Executive Staff Advisor Shields gave his report to the Board. The next trainings for the Crime Victims Compensation and Sexual Assault Examination programs have been scheduled for September 20, October 18, and November 15. All three (3) trainings will begin at 10:00 AM EST and will be conducted virtually through Microsoft Teams. Executive Staff Advisor Shields will be traveling to Cumberland Falls State Resort Park upon the conclusion of this month's meeting to represent the Board at the Kentucky Victims Assistance Academy. Executive Staff Advisor Shields also advised the Board that claims continue to increase. As of the date of this month's meeting, a total of twenty-five (25) claims have been filed with the Board.
