The new administrative regulations went into effect on September 2, 2025. Staff Attorney Bevins-Sullivan will conduct a training session on the new regulations immediately following the October 14, 2025 Board Meeting.

Executive Staff Advisor Shields gave his report to the Board. For the September 19, 2025 training, 48 people have officially registered. For the October 17, 2025 training, 34 people have officially registered.

19 Emergency Claims were decided in August, 2025 and none of those were outside of the statutory 14 day period.

Executive Staff Advisor shields will be heading to Louisville on September 12, 2025 to record the training video for Crime Victims Compensation and the Sexual Assault Program as required by House Bill 219.
