Board Chair Parsons called the meeting to order at 9:30 AM and conducted roll call.

The following individuals were in attendance at the meeting: Board Chair Parsons, Members Leenerts and Roberts, Executive Director Hardesty, Staff Attorney Bevins-Sullivan, Executive Staff Advisor Shields, Restitution/Collections Officer Barrie, and Investigators Hubbard and White.

Board Chair Parsons motioned to accept the minutes for the July 2022 meeting as drafted. Member Leenerts seconded the motion. All voted in favor of the motion. The July 2022 minutes were officially accepted as drafted.

Executive Director Hardesty gave his statistical report to the Board. Executive Director Hardesty also gave credit to the claims investigators for completing a large number of investigations and to Restitution/Collections Officer Barrie for her continued restitution/collections activities.

The Board discussed proposed policies on emotional support animals and bereavement leave and reviewed the draft policies prepared by Staff Attorney Bevins-Sullivan. After changes and minor edits, the Board expressed its desire to have revised policy drafts presented at the September 2022 meeting.

The national VOCA conference will be held the week of August 15, 2022 virtually on Monday (08/15), Wednesday (08/17), and Friday (08/19). Executive Director Hardesty, Staff Attorneys Bevins-Sullivan and Lile, Executive Staff Advisor Shields, Restitution/Collections Officer Barrie, and Investigators Hubbard and White will be in attendance.

Executive Staff Advisor Shields presented his report to the Board. The next training on the CVC program will be held on September 16, 2022 on Zoom. As of the date of the meeting, there have been approximately 35 registrants to the training.

Restitution/Collections Officer Barrie presented her report to the Board. She has recently completed a long-standing project of entering thirteen years' worth of Defendant information into the database. The Board congratulated Restitution/Collections Officer Barrie on the hard work that the project entailed.
