Board Chair Parsons called the meeting to order at 10:09 AM and conducted roll call.

The following were in attendance at the meeting: Board Chair Parsons, Members Leenerts and Roberts, Executive Director Hardesty, Staff Attorneys Lile and Bevins-Sullivan, Executive Staff Advisor Shields, Restitution/Collections Officer Barrie, and Investigators Hubbard and White.

Member Roberts motioned to accept the November 2022 meeting minutes. Member Leenerts seconded the motion. With all voting in favor, the motion carried.

Executive Director Hardesty gave his statistical report and thanked the Board for their work on clearing the backlog and reducing abeyance claims. Executive Director Hardesty mentioned to the Board that he had received notice from the Department of Medicaid that reforms and increases for CAC reimbursements have occurred. Prior to September 2022, the rate for CAC reimbursements was \$538. This has now increased to \$894.

Staff Attorney Bevins-Sullivan advised the Board that she needs to complete complete her revisions to the draft policy concerning emotional support animals. The Board tabled further discussion on the policy until the January meeting to allow Staff Attorney Bevins-Sullivan time to complete her revisions.

Executive Director Hardesty also discussed with the Board the potential for creating policies similar to that of the bereavement policy for other types of crimes, including physical violence. Executive Staff Advisor Shields will reach out to Dan Eddy regarding this policy to gauge whether any other compensation programs have such policies, what crimes they cover under such a policy, etc. The Board stated it wanted to see a draft policy before making a decision. The Board also stated it wanted to see the draft policy at the January meeting.
