# Crime Victims Compensation Board Minutes

January 28, 2022

Total Claims: 127

Executive Director John Hardesty reported to the Board that for December, 2021:

135 total claims were decided by the Board for December, 2021..

Board Chair Lanola Parsons officially called the meeting to order at 10:12 AM and performed roll call.

The following were in attendance at the meeting: Board Chair Parsons, Members Roberts and Leenerts, Executive Director John Hardesty, Staff Attorneys Shelby Bevins-Sullivan and Natalie Lile, Executive Staff Advisor Ray Shields, Restitution/Collections Officer Jennifer Barrie, and Claims Investigator Caleb Hubbard.

Board Chair Parsons motioned to accept the December 2021 meeting minutes as drafted. Member Leenerts seconded the motion. There were no abstentions or nays. The motion carried.

ED Hardesty gave his monthly report to the Board and introduced new Staff Attorney Natalie Lile. SA Lile provided her legal background and was officially welcomed by the Board.

ED Hardesty reminded the Board that their statements of financial disclosure are due by April 15, 2022.

The Ethics Commission will be offering one-hour trainings on executive branch ethics that will fulfill the CVCB's requirements. ED Hardesty will provide additional information on the trainings to the Board at a later time.

ED Hardesty reminded everyone that any time contacts are received from the media or are present at any events in which appearances are made by the Board or staff, the PPC's Public Information Officer will need to be consulted.

ED Hardesty advised the Board that their Senate confirmations are moving thorugh the process and no problems are anticipated. ED Hardesty will notify the Board once their confirmations have cleared.

The Board discussed implementing a policy regarding service providers unlawfully submitting victims' claim related expenses to collections despite receiving the Notification of CVCB Investigation form from the victims. The Board determined that cease and desist orders should be served certified so no provider can say they did not receive the letter. ED Hardesty and SA's Bevins-Sullivan and Lile will consult and develop a cease and desist order for approval by the Board at a later date.

Board Chair Parsons commended ESA Shields for his recent presentation to the Harlan Chamber of Commerce on January 12, 2022. The presentation was very well received. ESA Shields advised that he has been contacted by the co-chair of the Statewide Human Trafficking Task Force, FBI Victim Specialist Cassie Young, and has been asked to speak with the Task Force about the Kentucky crime victims compensation program. The presentation, pending official approval, will be given on February 18, 2022.

The Board also discussed setting a policy to allow for awards for lost earnings to be granted for a stipulated period of time automatically. ED Hardesty will consult with Dan Eddy (National Association of Crime Victims Compensation Boards) to see how other states have handled setting such a policy and will advise the Board of his findings at a later date.

The next Board meeting for the CVCB will be held on February 8, 2022 at 10 AM at 500 Mero St., Frankfort, KY 40601 in conference room 259SW with a Zoom option for the public.
