Board Chair Parsons called the meeting to order at 10:05 AM and conducted roll call.

The following individuals were in attendance at this month's meeting: Board Chair Parsons, Members Leenerts and Roberts, Executive Director Hardesty (virtually), Staff Attorneys Bevins-Sullivan and Lile, Executive Staff Advisor Shields, Investigators Hubbard and White, and Restitution/Collections Officer Barrie.

Executive Director Hardesty provided his Director's Report to the Board. Executive Director Hardesty also provided updates to the Board on SB 282 and SB 283. It does not appear that SB 283 will move this session. However, SB 282 has passed out of the Senate unanimously and is currently with the House. If passed, SB 282 will increase statutory caps on funeral/burial expenses to \$7,500 and lost earnings/support awards to \$300 weekly. In addition, SB 282 would increase the overall award cap to \$30,000 and would allow for awards in hit and run situations. SB 282 also contains an emergency clause, which would cause the legislation to take immediate effect. Executive Director Hardesty also reminded the Board that their Statements of Financial Disclosure are due on April 15, 2023. Executive Director Hardesty also reminded the Board that he will not be in attendance at the April 2023 meeting as he will be on paternity leave.

The Board tabled discussion on the expanded lost earnings policy until the April 2023 meeting.

Executive Staff Advisor Shields provided his report to the Board. The next training dates on the CVC program are scheduled for March 17, 2023 and April 21, 2023. There are 90 registrants for the March training and 47 for the April training. Four more individuals expressed interest in registering right before the meeting. Executive Staff Advisor Shields also advised the Board that the docket for the April meeting will be quite large as well and suggested that the Board plan on holding an extended meeting.
