The following were in attendance at the meeting: Board Chair Parsons, Members Roberts and Leenerts, Executive Director Hardesty, Staff Attorney Lile, Executive Staff Advisor Shields, Investigators Hubbard and White, and Restitution/Collections Officer Barrie.

Board Chair Parsons motioned to accept the minutes from the October 2022 meeting. Member Leenerts seconded the motion. With all voting in favor, the motion carried.

Executive Director Hardesty gave his statistical report to the Board. Executive Director Hardesty also brought to the Board's attention that staff have been working with the legislative working group regarding potential improvements to the CVC and SAE programs. Discussions are going well. The next step will be for a draft bill to be written. Executive Director Hardesty will circulate the draft bill to the Board once it has become available. Executive Director Hardesty also commended the investigators for keeping claims moving through the claims process, to Restitution/Collections Officer Barrie for increasing restitution figures, and to SAEP Coordinator Greene for her hard work on processing SAE claims.

Executive Staff Advisor Shields mentioned that the next two trainings on the CVC program are scheduled for December 16, 2022 and January 20, 2023. Executive Staff Advisor Shields also mentioned that he had conducted a training on the CVC program with advocates from the National Guard in Lexington on October 28, 2022. Executive Staff Advisor Shields will also be staffing a table at the KASAP annual conference in Lexington from November 30, 2022 through December 2, 2022 and will be speaking with advocates at Fort Knox during the first week of December.
