## MINUTES

## BUSINESS

The Board meeting was called to order on February 23, 2022, at approximately 1:00 pm, via video conference, having been duly posted on the website.

Voting board members present: Chair, Frederick Higdon, Board members Tony Colyer and Melinda Karns. Staff members present: Staff Attorneys Shelby Bevins-Sullivan and Natalie Lile, Executive Director John Hardesty, and Clerk Anne Duvall. Hearing Officers Eden Stephens and Shawn Chapman were also present.

The minutes from the January 26, 2022 meeting were approved and adopted. Motion to approve made by Ms. Karns and seconded by Mr. Colyer. Having all in favor, the motion carried.

Revenue, K21-R-001 Hale, Inc. d/b/a Lotsa Pasta v. Revenue, K21-S-064 The Solomon Foundation v. McCracken Co. PVA, K21-S-065 The Solomon Foundation v. Fayette Co. PVA, K20-S-034 Lowe's Home Centers, LLC v. McCracken Co. PVA, and K21-S-049 Vincent Smith v. Fayette Co. PVA. - f. K21-S-049 Vincent Smith v. Fayette Co. PVA Recommended Order by Hearing Officer. Ms. Karns recused herself from this matter. Motion to accept hearing officer's Recommended Order made by Mr. Colyer and seconded by Mr. Hidgon. Having reached a consensus, the motion carried.
