### **NEGLIGENCE CLAIMS AGENDA**

KCC May 2020 Monthly Report

The Kentucky Claims Commission received **51** negligence claims filed against the Commonwealth during the month of May, 2020.

The Claims Commission decided **50** claims under \$2,500.00 in May, 2020. Of those, **12** were dismissed and **38** were awarded for a total amount awarded of **\$20,802.51**.

At its meeting on May 26, 2020, the Commission awarded 5 negligence claims in the total award amount of \$18,136.48 and dismissed 4 other claims. Together with the claims investigated in-house, the Commission decided 59 claims altogether while dismissing a total of 16 negligence claims and awarding a total of 43 negligence claims for a total amount awarded of \$38,938.99 in March, 2020.
