***NEGLIGENCE CLAIMS AGENDA***

**KCC March 2020 Monthly Report**

The Kentucky Claims Commission received **53** negligence claims filed against the Commonwealth during the month of March, 2020.

The Claims Commission decided **51** claims under \$2,500.00 in March, 2020. Of those, **13** were dismissed and **38** were awarded for a total amount awarded of **\$22,764.32**

At its meeting on March 28, 2020, the Kentucky Claims Commission dismissed **1** negligence, awarded no other negligence claims, and upheld **1** prior small claims dismissal. Together with the claims investigated in-house, the Commission decided **53** claims altogether while dismissing a total of negligence claims and awarding a total of negligence claims for a total amount awarded of **\$22,764.32** in March, 2020.

**KCC April 2020 Monthly Report**

The Kentucky Claims Commission received **37** negligence claims filed against the Commonwealth during the month of April, 2020.

The Claims Commission decided **15** claims under \$2,500.00 in April, 2020. Of those, **6** were dismissed and **9** were awarded for a total amount awarded of **\$5,090.15**

At its meeting on April 26, 2020, the Kentucky Claims Commission considered no additional negligence cases.
