KCC January 2020 Monthly Report

The Kentucky Claims Commission received **59** negligence claims filed against the Commonwealth during the month of January, 2019.

The Claims Commission processed and/or decided **32** claims under \$2,500.00 in January, 2020. 23 were dismissed and 9 were awarded, for a total amount awarded of **\$7,613.65**.

At its meeting on January 25, 2020, the Kentucky Claims Commission dismissed 6 claims. Together with the claims investigated in-house, the Claims Commission dismissed a total of **29** negligence claims and awarded a total of **9** negligence claims for a total amount awarded of **\$7,613.65** in January, 2019.
